#### **Application Information and Guidelines**

(Please read carefully before completing the application. NOTE: This is a 2-page document. You will find the Proposal Application Form following these Guidelines.)

Redlands Education Partnership (REP) believes strongly in keeping The Arts in all schools. Both the National School Boards Association and Americans for the Arts agree that The Arts serve as a critical component to a complete education and are proven to increase student academic achievement.

### **CRITERIA:**

- A complete project application must be submitted to REP by **SEPTEMBER 23, 2016.**
- Project(s) should present clear and concise statements of purpose, goals, and objectives
- Project(s) should involve students, teachers, parents, and/or community members

### **OTHER REQUIREMENTS:**

- Each application must be approved and signed by the School Principal
- All materials purchased become the property of the Redlands Unified School District
- The REP Committee reading the applications has the right to decline project proposals. Schools may submit another proposal with a new deadline to replace the declined proposal.
- The Project Evaluation Form must be submitted to REP by MAY 12, 2017, along with all receipts from expenditures, photos, and any press releases

#### **GUIDELINES:**

- Each school year, schools must spend a minimum of 45% of their total T.A.G.S. Funding on The Arts. The remaining percent of a school's funding may be spent in one or more areas of Technology, Arts, School Gardens, and Science. However, no more than \$500 can be spent toward School Gardens.
- Receipts <u>must</u> be kept for all expenditures and submitted to REP with the Project Evaluation at the end of the school year.
- A school may "team up" with another school(s) to bring an artist-in-residence for dance choreography in P.E. to demonstrate specific art techniques, drama, or music. This is not limited to The Arts.
- A school may propose a specific project which would "bank" their current year's funding in combination with the following year's funding. This proposal must include details, expenses, and reasons why they are requesting to "bank" their current year's funding. The two-year activity scheduled and the money requested <u>must</u> be completed by the end of the second year. This excludes 45% spent for The Arts.
- A school may reference a previously funded project when applying for current funding to add another phase or expansion to the successful previous project.
- Project choices in Technology, Arts, Gardens, and Science may include, but are not limited to, assemblies, non-fiction library books, field trips, science camp, family night events, permanent as well as disposable supplies, and teacher enrichment supplies and equipment.
