GRANTS FOR TEACHERS 2024-2025 INSTRUCTIONS

Redlands Educational Partnership (REP) is extremely proud to present *Grants for Teachers 2024-2025*. REP's mission is threefold: to make education a priority in the community, to enhance our students' learning opportunities and to better prepare Redlands Unified School District students to become contributing members of our society. We appreciate the commitment our teachers dedicate to our students and developing their individual brilliance. Grants of \$500 per teacher are available for this school year. REP would like to thank Mr. Jack Barton, owner of Mathnasium, for his generous funding of four Mathnasium grants this year.

ELIGIBILITY:

Only full-time contracted teachers in the RUSD may apply for *Grants for Teachers*. Grade levels or departments can collaborate to submit applications for group purchases. This information should be noted on each Application for the group and should also list the names of the other applicants of the group.

ALLOWABLE GRANT EXPENSES:

Allowable expenses may include: hardware such as robotics, digital cameras, coding devices, etc. Software with a clear educational benefit. Materials for art, music, literature, science, math, and physical education. Furniture and equipment that supports innovative and flexible instruction. Field trips and in person experiences to enhance the curriculum.

GRANT DEADLINES:

1. September 23, 2024 application period opens.
2. October 18, 2024 application period closes, or when all funds have been exhausted.
3. February 28, 2025 evaluations and receipts are due.

REP-MATHNASIUM MATH GRANT:

Mathnasium of Redlands is sponsoring four \$500 Grants for teachers. The focus for these 4 special grants will be for enhancing Math instruction in Redlands. Some suggestions that will be considered for this special grant are:

- Hardware such as Robotics, coding devices and scientific calculators.
- Math manipulatives and consumables.
- Math focused online Professional Development. Please note that the course should be taken on your own time.

RESPONSIBILITIES OF GRANT RECIPIENTS:

- Agree to cash check within 30 days of receipt. Funds will be spent in the current school year. Receipts and Evaluations will be submitted before the above deadline. All Grant recipients give their consent to REP to produce, reproduce, edit, print, trade or share content (videos or moving photographs, illustrations, images, likeness, sound, and statements or comments) as desired.

If you were a Grant recipient in the 2023-2024 school year and failed to submit your receipts and Evaluation on time, please do not apply this year. You may reapply in the 2025-2026 school year.
